All members shall participate in and submit an annual Continuing Professional Development (CPD) declaration to the Institute of Chartered Professional Accountants of Saskatchewan (CPA Saskatchewan) (*Bylaws 23.1 and 23.8*).

When a member declares an instance of non-compliance with the minimum CPD requirements of a calendar year and declares to fulfill the CPD deficiency, the member shall undertake learning activities within that calendar year equal to the deficiency in addition to the minimum CPD requirements established in Bylaws 23.2, 23.3, and 23.4 of Board Rules 323.12 and 323.13, if applicable, and complete the learning activities within that calendar year (January 1 – December 31) (*Rule 323.21*).

Under Rule 323.22, the Registrar shall review the member's declaration in Board Rule 323.21:

- (a) accept the member's declaration;
- (b) request a written submission with particulars on how the CPD deficiency will be fulfilled; or
- (c) refer the matter to the applicable regulatory committee.

The member shall have conditions or restrictions placed on their registration until the CPD deficiency is fulfilled (*Rule 323.23*).
