

Exemption Request to Licensing Qualifications

Exemptions are available to licensing qualifications in the following circumstances (Rule 316.19):

For a comprehensive or specified licence application:

- Your minimum practical experience hours are below 1,250 over the past 5 years (initial applications for comprehensive or specified licence or on comprehensive licence renewals)
- Your minimum practical experience hours are below 625 over the past 5 years on specified licence renewals
- Your minimum practical experience hours are below 625 relating to audits of historical financial information on initial application or renewal of a comprehensive licence
- You were supervised for less than 2 years by the licensed member providing your competency assessment
- You did not obtain depth in assurance and/or the financial reporting competency in your education program but are seeking exemption to the requirement to complete the Post Designation Public Accounting (PDPA) Program

For a compilation licence application:

You have completed less than 15 compilation engagements over the past 5 years

This Exemption Request Form will be included as part of your licence application for consideration by the Professional Practice Committee. Please ensure that no identifying information relating to you, your firm, clients, or staff are included in this form.

The Professional Practice Committee may approve your exemption request, may impose conditions or restrictions on your licence or may cancel your licence based on information included within your licence application and this form. All licence exemptions and conditions are listed on a member's licence. All licence cancellations or restrictions are published on CPA Saskatchewan's website and within the firm and member newsletters.
